What's an intervention?



## **Intervention Categories**

### Advice & Information

General advice, information leaflet, screening e.g. AUDIT

### Brief Intervention

Face to face, typically one session lasting around 5-10 mins







## **New Intervention Categories**

### Advice or Minimal + Intervention



Delivery of advice or feedback, may include provision of a patient information leaflet

### Simple Brief Intervention

Structured simple brief intervention, often completed in one session and typically around 5-10 minutes

**Engagement or** Support **Activities** 

### Extended Brief Interventions

Extended interventions e.g. counselling or motivational interviewing, initially one session with follow-up sessions if required,

typically sessions last 20-30 minutes



### • Brief Treatment

Includes a range of treatments such as Motivational Interviews or CBT, typically delivered in 1 to 5 sessions of around 30-60 minutes



## **Intervention Types**

- Can be used to capture the content (and sometimes also context) of an intervention
- Enable monitoring and reporting of particular activities
- Descriptions tailored to service requirement





## **Intervention Types - Limitations**

- 'Other intervention' combined with free text notes
- Ability to recording activity 'outcomes'
- Additional work required to capture multiple events occurring within one interaction activity
